It is informed that One Time Settlement Schemes issued vide notification no. 4740-C-7-19/9165-67 dated 10.09.2019 for PACS have been modified by the Government as under:-

1. OTS-2019 for PACS

1(ii) Eligible Beneficiaries

- a. The word "all those loanee members (Loan Accounts) of PACS" in Para-1(ii) of the notification, besides S.T. Agri (Crop Ioan) A/c includes loanee members who have availed Medium Term Agri, Medium Term Non Agri, Rural Artisans, Petty Shopkeepers and Consumptions Loans.
- b. Legal heirs of deceased members are eligible to avail the benefits of the Scheme by paying the amount of Principal on behalf of the deceased members.




