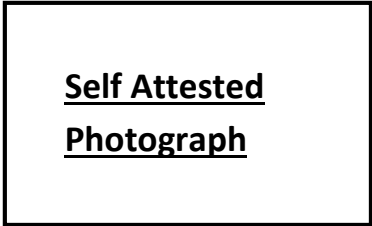
1. Scrutiny of title deeds.
